With reference to the above cited subject, as per reference (1) a conditional Fire Safety Recommendation was issued to the premises of at "Authorised Signatory, Edify School, No 226/227, Somanahalli, Kanakapura main road, Bengaluru" with a condition to fulfill all the recommendations stipulated in fire safety recommendation and compliance the same within 3 months and as per reference (2) the Fire Safety Compliance Report was issued for the same.

With reference cited (3) above, the management of 'Authorised Signatory, Edify School, No 226/227, Somanahalli, Kanakapura main road, Bengaluru School' had requested for the renewal fire safety compliance report from our department. In this regard the above school building was inspected by FSO Anjanapura Fire Station on 18-10-2024 to check the compliance of all the recommendations stipulated in fire safety recommendation & on inspection it was found that all the recommendations stipulated in fire safety recommendation has been complied.

Under the above circumstance the Karnataka Fire & Emergency Services Department is issuing the "Authorised Signatory, Edify School, No 226/227, Somanahalli, Kanakapura main road, Bengaluru" subject to proper maintenance of firefighting installations in the good working conditions and arrange for 40% of staffs/employees training within 03 months from the date of issue of this report.
